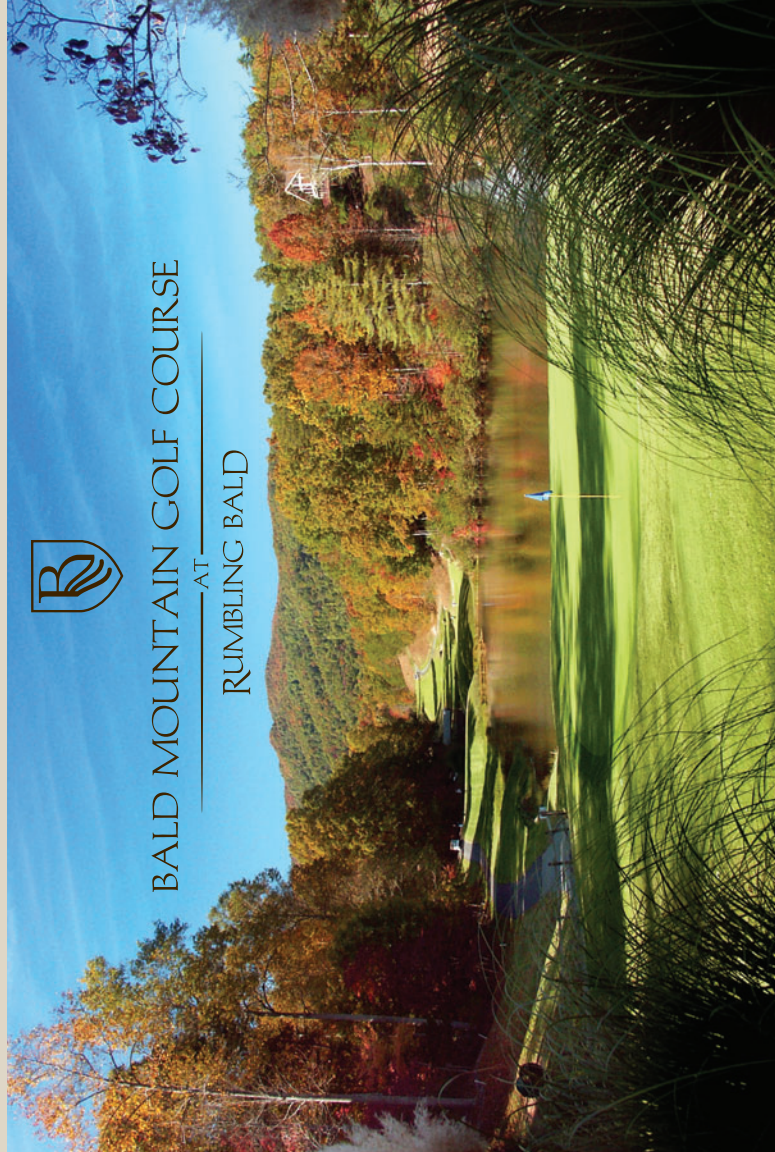
USGA Rules Govern All Play

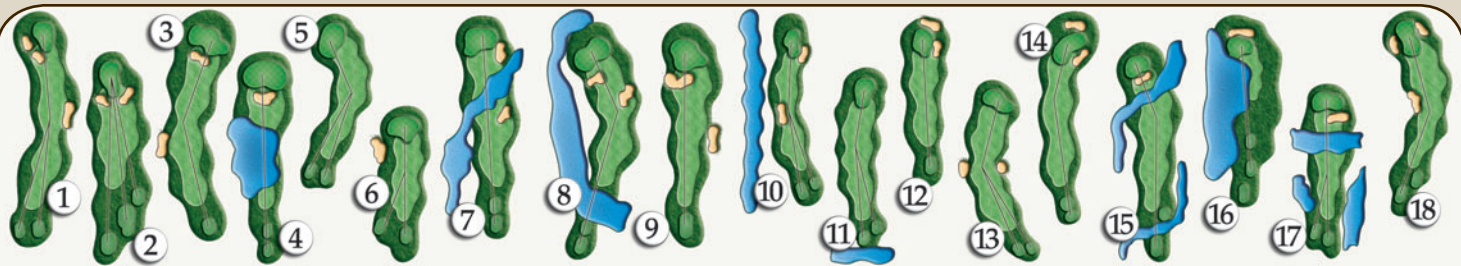
1. All players must register in Golf Shop before playing. Teeing off the 10th tee is not permitted without checking with the Golf Shop.
2. Golf Cars: A valid drivers license is required for operators. Golf cars are for use while playing golf ONLY. Only two individuals and two bags per car. Keep golf cars off slopes. Use golf car paths whenever possible and obey all directional signs. Car damage repair costs will be divided equally between the occupants.
3. Proper dress is required at all times. Men must wear shirts with collar. Ladies please cover midriiffs. Bermuda length shorts permitted, no cut-offs allowed.
4. Speed of play for a round of golf is 2 hours and 5 minutes per 9 holes of play with a turn time of 5 minutes for a total of 4 hours 15 minutes.
5. Repair all ball marks on greens. Rake imprints in sand traps. Sand and repair all divots.
6. Remember to always keep pace with the group ahead of you.
7. Any ball crossing or lying on any paved road is out of bounds.
